

WARRANTY

MOD Cycles Corporation (MOD) warrants that each new vehicles distributed by the company through its authorized Dealers will be free from defects in materials and workmanship under normal conditions of usage, SUBJECT to the following TERMS AND CONDITIONS:

- **1. Conditions for Eligibility.** The warranty shall be valid only if the Baccio unit has been delivered and subsequently serviced by a Baccio Authorized Dealer, according to the Pre-Delivery Inspection checklist and periodic maintenance chart. The Warranty Registration Card has been completed in full, and sent to MOD.
- **2. Period of Validity.** MOD's warranty for every Baccio unit shall be valid for a maximum of 1 month or 1,000 miles (whatever happens first) only for parts. LABOR COST OF A REPAIR OR REPLACEMENT IS NOT COVERED BY THIS WARRANTY.
- **3. MOD Cycles Corp. obligations under this warranty.** If any manufacturing defect is detected in any vehicle within the warranty period established in section two (see above), MOD will replace the defective part at no cost to the owner . Mod has in any and all cases the final decision on warranty claims and their validity.

4. LIMITATIONS.

I - The warranty shall not apply to:

a) Any vehicle that has NOT been used in accordance with the operating instructions mentioned in the owner's manual of such vehicle.

b) Any vehicle that has NOT been serviced by an Baccio Authorized Dealer during the warranty period and/or following the maintenance chart included in the owner's manual of such vehicle.

- c) Any vehicle that has been used for commercial purposes.
- d) Any vehicle that has been used for competitions and or races of any kind.
- e) Any vehicle fitted with accessories other than those approved by MOD.

f) Any vehicle that has been altered or modified in any way from its original configuration as delivered by MOD, for any purpose or use whatsoever.

g) Any damages, defects, malfunctions (mechanical or not) occurred as the consequence of misuse or negligence.

h) Any vehicle serviced and/or repaired by any OTHER than a Baccio Authorized Dealer.



II - The following items are not covered under warranty

Batteries, all electric and electronic parts (CDI unit, voltage regulator, spark plugs, bulbs, etc...). All parts subject to normal wear and tear like brake shoes, pads and drums, discs, clutch discs, tires, tubes, chain, sprockets, belts and similar items.

5. Owners responsibilities - In order to maintain this warranty in effect for the maximum length explained in section two (see above) the owner must make sure the Pre-Delivery Inspection checklist has been completed in full by the Baccio Authorized Dealer, before accepting delivery of the Baccio unit. Provide this booklet to the Authorized Dealer whenever they are providing any and all of the services, inspections and warranty claims that you, the owner, request.
